
Five Commissioners, appointed by the Governor of the State of South Carolina, are responsible for policy making decisions and goal setting for future development of the agency.

ICRC currently operates five signature parks which provide an array of recreational opportunities for youth, teens, adults, seniors, and individuals with cognitive, physical, and emotional disabilities.

Programming and special events offered by ICRC throughout the year are centered within the parks. Over the years, ICRC has earned a reputation for program and facility excellence that has attracted participants from surrounding counties. This positively impacts the financial position of the agency as user fees support a majority of ICRC's operational budget.




## YOUR DOLLARS At Work General & Special Revenue Funds

Only 38.59% of the funding that supports the operation of ICRC parks comes from tax dollars.

The remainder of the operating budget comes from fees for programs, services, and special events, contributions, grants, and interest income.

To help offset limited budgets, ICRC pursues grant opportunities to provide additional funding for facilities and programs. ICRC successfully secured grants from LWCF, PARD, and CDBG, as well as a corporate grant from Dominion Energy.

This funding allows the agency to improve facilities and add additional amenities to our parks without impacting district tax payers.



## 2023-24 Highlights

#### Afterschool Programs

The Irmo Chapin Recreation Commission (ICRC) offered quality after-school programs to an average of 739 children per day.

#### **Therapeutic Recreation**

ICRC offers programs for children and adults with special needs and considerations. Our purpose is to provide recreational and skill building opportunities that enhance socio-emotional development and self-confidence. We provide an adaptive and inclusive environment that enhances participant's independence. ICRC continued to offer after-school programs to *an average of 30 individuals per week*, and *140 summer campers*. ICRC was awarded *\$85,311 in grant funding* for the district-wide after-school program and *\$18,616* for its new adult enrichment day programming.

#### Summer Camps

Summer Safari day camps at Crooked Creek Park and Seven Oaks Park served *364 children* each week for ten weeks. Extreme Safari, a day camp for ages 11–14, served *50 children* weekly. Additionally, ICRC offered *176 specialty camps* for children of all ages and interests at our parks.

#### **Children's Theatre**

ICRC's Children's Theatre program hosted four live performances in 2023-24. A total of *124 children* participated in the program, performing to *2,898 audience members*.

#### **Health and Wellness**

Health and wellness programs at Crooked Creek Park and Seven Oaks Park offer wellequipped fitness centers, a variety of classes, and indoor walking tracks.

#### **Senior Services**

ICRC serves as the area's Council on Aging, making Crooked Creek Park and Seven Oaks Park key providers of senior services in the community. Support services include: Mealson-Wheels, group dining sites, transportation, health and wellness programs and more. ICRC *served 17,835 meals to seniors this year.* The agency received generous *donations of \$48,805* from the community in support of the Meals-on-Wheels program.

#### Athletics

ICRC had *5,355 participants* in our youth and adult athletic leagues which included: lacrosse, softball, football, flag football, cheer, soccer, indoor soccer, cross country, track, baseball, basketball, volleyball, and golf.

#### Market Development Tournaments and Events

During FY 2023-2024, ICRC hosted *57 sports tourism events* headlined by the Columbia Volleyball Club the "Clash." Additional events included 5Ks, fun runs, baseball, softball,

lacrosse, and flag football tournaments. These events *brought 149,767 visitors* to ICRC facilities with an estimated *economic impact* of \$3,526,203.

#### **Environmental Education Programs**

Environmental Education Programs which address national and South Carolina education science standards are offered to schools throughout the region. These programs offer students hands-on experience learning about plants, animals, and the environment. Each program consists of a short lesson, an opportunity to handle various preserved plant and animal specimens, and a nature walk. *More than 5,823 children* participated in environmental education programs at Saluda Shoals Park.



#### **Environmental Stewardship**

Protecting and enhancing our resources is vital throughout the District and ICRC contributes in several ways. This year, through a grant from Dominion Energy, Saluda Shoals Park completed important restoration work including removing invasive privet, planting native species, completing bank restoration, and digging a well to improve the Wetland Preserve located in the park. The Wetland Preserve is home to many species of plant and animals and serves as an environmental education classroom for thousands of school children each year. The parks also recycle all paper and plastic waste and Crooked Creek Park participates in Chapin Community Service Day annually.

#### **Special Events**

ICRC offers a variety of special events each year, which attracted *more than 370,800 people* to our parks. Events include: Astronomy nights, athletic tournaments, Backyard Saturday, Bowl Day, Candy Cane Hunt, Cooking with Santa, cross country and track meets, Daddy Daughter Dance, EGG-cessible Egg Hunt, Fall Craft Market, Flashlight Egg Hunt, Indoor Yard Sales, Halloween at the Park, Halloween at Saluda Shoals Park, Holiday Lights on the River, Holiday Market, Howl-O-Ween at the Bark, Kite Day, Lower Saluda Craft Beer & WineFest, Opening Day, Outdoor Movie Night, Paddle and Pint, Pickin' & Piggin' BBQ Cookoff, Preschool and Special Friends Egg Hunt, Saluda Shoals Egg Hunt, Saluda Shoals Jazz Series and Music Series, Santa's Market Craft Show, Shuckin' on the Shoals, Sleigh Bell Trot and Stroll, Slip, Slide & Splash, Spring Market, Soggy Doggy Day, Sunset on the Shoals, Touch-a-Truck, and Winter Wine at Holiday Lights.

#### **Meetings and Rentals**

ICRC offers many opportunities to gather at our parks for both business and social functions. Crooked Creek Park, Melvin Park, Saluda Shoals Park, and Seven Oaks Park offer picnic shelters as well as indoor meeting rooms. For larger meetings, weddings, and events, the River Center at Saluda Shoals Park and the Meech House at Mungo Park offer elegant spaces to gather. ICRC had *7,381 indoor and outdoor facility rentals* this year *generating \$1,000,000 in operating revenue* for the agency.

ICRC's largest annual special event, Holiday Lights on the River, was held November 22<sup>nd</sup> through December 31<sup>st</sup>.

Revenue generated from this event is necessary for the operational support of Saluda Shoals Park.

More than 110,700 people made Holiday Lights part of their family traditions and the event had an estimated \$3 million dollar economic impact on our community.





## SALUDA SHOALS FOUNDATION

Since 1997, the Saluda Shoals Foundation has supported Saluda Shoals Park. The Foundation is a nonprofit 501(c)(3) organization committed to serving as a steward of the park through financial support and as an advocate for the preservation and sustainability of the park's programs and the environment. The community gives generously each year during the Foundation's annual campaign and other fundraising events. Fundraising efforts in FY 23-24 brought in more than \$378,000.

- Individuals and companies gave more than \$87,000.
- The annual Shuckin' on the Shoals Oyster Roast fundraiser grossed more than \$30,000 from sponsorships, ticket sales, and raffle sales.
- Dominion Energy awarded a \$37,600 grant to support environmental education programs and to upgrade the wetland area with a new well, replace invasive plants with natives, and also supported a new family health initiative to the park, called TRACK Trails, with a \$19,700 grant.
- The CW and Dorothy G. Love Foundation awarded a \$20,000 grant in support of Public Art projects at the park.
- Leo's Pride donated \$30,000 in support of expansion and upgrades to the Therapeutic Recreation facilities at Seven Oaks Park.

Generous donor gifts supported park programs and events including the following:

- An evening at Holiday Lights on the River for more than 200 Ft. Jackson soldiers.
- Park programs and events including Backyard Saturday, Lower Saluda Craft Beer & Winefest, Holiday Lights on the River, Egg-Cessible Egg Hunt, Pickin' & Piggin' BBQ Cookoff, fall and spring Music Series, Special Olympics Tennis team practices and numerous paddle programs.

#### **Public Art**

The Saluda Shoals Foundation Public Art Committee began planning two major art installations for the coming year. The first will incorporate the water mains along the newly widened trail to feature unique murals that reflect nature-inspired themes. The second will bring back our old friends from the wetland, the hanging fish by artist Mike Williams, to a new prominent location with a creative display.

#### **Environmental Education Center Renovation Project**

Constructed in 2001, the Environmental Education Center features a unique architectural design, and its educational offerings and amenities were developed as a part of Saluda Shoals Park's original Master Plan. The Education Center has served a vital role over the years, but the building now requires infrastructure repairs and has become underutilized in meeting the future vision of Saluda Shoals Park. ICRC and the Saluda Shoals Foundation plan to renovate and upgrade the Education Center, establishing the facility as a Visitor Center along the planned expansion of the Lower Saluda Greenway Trail.

The planned expansion of the Greenway Trail will connect the Lake Murray Dam Walkway to the Saluda Riverwalk utilizing the riverfront trails within Saluda Shoals Park. Bikers, hikers,

and park visitors will be able to enter the park from either direction. The Environmental Center is the only public facility currently on the trail and, once renovations are complete, could act as a meeting place, hub, destination, trailhead, and rest area for trail users. Renovations and updates to the Environmental Center may include the following:

- Expansion of the outdoor deck for education and events.
- Converting the existing auditorium into the building's main entrance.
- Adding additional ADA accessible restrooms to support large gatherings.
- Adding a bistro and concession area for visitors to enjoy.

The Environmental Center project will be developed in phases based on funding secured through grants and fundraising activities.
