Mark Smyers presented an overview of the agenda items as follows:

Mr. Smyers provided an update on the Mungo Park bridges; staff are waiting on the final deed and title for the property at the bridge sites. The Meech House has a church interested in rental opportunities; discussion occurred regarding rental fees and other potential customers.

Mark Smyers shared that full-time staff returned to regular full-time hours on Monday, October 26, 2020; the shift from a 20% reduction back to full pay was well received; no staff left the agency due to the cut in pay; there were three planned retirements. Discussion occurred regarding the fund balance. Mr. Smyers shared that no PPE or Cares Act dollars were available for the agency as a Special Purpose District. Discussion occurred regarding Cares Act, customers, resources to support the agency, and management of the agency's cash flow.

Mr. Smyers communicated that programmatically the agency is operating at 50%- 70% of normal operations; staff are looking at the efficiencies of the agency and how comfortable the community is willing to return to park and recreational opportunities. Mark Smyers shared the timeline of closing the tennis courts in Chapin; bids will begin in November and final closure of the courts at Crooked Creek Park will occur in January; staff will advertise to the public ahead of time.

Discussion occurred regarding the opportunity to acquire additional property connected to Mungo Park; the attorney is reviewing the resolution. Mr. Smyers shared that a citizen is requesting an easement within Mungo Park; the easement request is for an underground power line through Dominion right of way. Discussion occurred regarding location and future development.

There being no further discussion, the Commission moved to the General Session.
